Cilji in kompetence:

Osnovni cilj prakse je poudariti pomen povezanosti pravne teorije s pravno prakso, ki po končanem študiju študentu omogoča uspešno vključitev v delo s področja študijskega programa.

Študent osvoji naslednje splošne in predmetno specifične kompetence:

- sposobnost uporabe znanj s pravnih področij;
- obvladovanje raziskovalnih metod, postopkov in procesov s področja družboslovja ter razvoj kritične in samokritične presoje na družboslovnem področju,

- kolegalnost do sodelavcev in lojalnost delodajalcev ter sodelovalnost, delo v skupini ter strpno sprejemanje in upoštevanje tvornih kritik in pripomb,
- sposobnost za reševanje konkretnih strokovnih problemov z uporabo znanstvenih metod in postopkov,
- koherentno obvladovanje temeljnega znanja, pridobljenega predvsem pri obveznih predmetih ter povezovanje znanja z različnih področij in njegova uporaba v poslovnem okolju,
- razumevanje in uporaba kritične analize in razvoja teorij ter njihova uporaba v reševanju konkretnih strokovnih problemov,
- razvoj veščin in spretnosti v uporabi znanja na posameznem strokovnem področju.

Objectives and competences:

The basic goal of the internship is to emphasize the importance of the connection between legal theory and legal practice, which enables the student to successfully integrate into work in the field of the study program after completing the studies.

The student acquires the following general and subject-specific competencies:

- *ability to use knowledge from legal fields;*
- *mastery of research methods, procedures and processes in the field of social sciences and the development of critical and self-critical judgment in the field of social sciences,*
- *autonomy in professional work and making business decisions,*
- *collegiality towards colleagues and loyalty of employers as well as cooperation, teamwork and patient acceptance and consideration of constructive criticism and comments,*
- *the ability to solve specific professional problems using scientific methods and procedures,*
- *coherent mastery of basic knowledge acquired mainly in compulsory subjects and the integration of knowledge from different fields and its application in the business environment,*
- *understanding and use of critical analysis and development of theories and their use in solving specific professional problems,*
- *the development of skills and abilities in the application of knowledge in an individual professional field.*

Predvideni študijski rezultati:**Intended learning outcomes:**

Študenti znajo uporabiti svoje pridobljeno pravno znanje na konkretnih pravnih primerih, sicer na začetnem nivoju, kar pa je vendarle pomembno za njihovo nadaljnjo pot v pravni praksi.

The students are capable of using their legal knowledge obtained in the course of study to resolve legal problems at a practitioner-beginner's stage, however, which is already very important for their career to follow in legal practice.
