Predmet delovno pravo obravnavana naslednja osnovna področja: <ul style="list-style-type: none"> - nacionalni in mednarodni viri delovnega prava, umestitev delovnega prava v pravni sistem; - definicija delovnega prava (pojem, vrste), definicija delovnega razmerja in njegovo razmerje do drugih pogodb civilnega prava; 	The course on Labour Law at the undergraduate level includes the following basic concepts: <ul style="list-style-type: none"> - national and international sources of labour law, the position of labour law in legal system; - definition of labour law (concept, different types), definition of employment relationship and its relation to other civil law contracts;

<ul style="list-style-type: none"> - sklenitev delovnega razmerja, bistvene sestavine pogodbe o zaposlitvi, vrste pogodb o zaposlitvi, odpoved pogodbe o zaposlitvi in drugi načini prenehanja delovnega razmerja; - pravice in obveznosti delavcev in delodajalcev iz delovnega razmerja; - postopki varstva pravic delavcev pred delodajalcem in v sodnem postopku - kolektivni dogovori in kolektivne pogodbe, stavka, sodelovanje delavcev pri upravljanju; - delovno pravo in pravo EU. <p>Predmet na dodiplomski ravni študija obravnava osnove delovnega prava, razvoj delovnega prava, študentke in študenti pa se seznanijo z njegovimi temeljnimi instituti in značilnostmi. Obravnavana so tudi posamezna aktualna vprašanja glede na razvoj teorije, zakonodaje in sodne prakse.</p>	<ul style="list-style-type: none"> - conclusion of employment relationship, employment contract and its elements, types of employment contracts, termination of employment contracts; - rights and obligations of employees and employers from the employment relationship; - proceedings for protection of employees' rights before the employer and in court proceedings; - collective bargains and collective agreements, strike, participation of employees by management - labour law and EU law. <p>At the undergraduate level the course deals with basic labour law concepts, development of labour law, the students are familiarised with its basic institutes and characteristics. According to the development of theory, legislation and case-law the course also analyses current issues related to labour law.</p>
