Prijava obsega prošnjo, v kateri študent zaprosi za sprejetje prijave teme doktorske disertacije z navedbo naslova predlagane doktorske disertacije in področja, na katerem bi študent želel izdelati doktorsko disertacijo, ter s predlogom mentorja.

Content (Syllabus outline):
 The student typically submits the application for the doctoral dissertation topic to the study committee in the first semester of the first year of study. Once the faculty senate approves the dissertation topic and appoints a mentor, the student can begin preparing the draft proposal of the doctoral dissertation.
 The student presents the results of the research work in written and oral form publicly before a committee for the evaluation of Doctoral Seminar 1, appointed by the Senate of the

V skladu s Pravilnikom o študiju na doktorskih študijskih programih Evropske pravne fakultete Nove univerze študent med drugim predstavi teoretske temelje proučevane tematike, raziskovalni načrt z raziskovalnimi vprašanji in metodologijo. Študent pojasni tudi pričakovano znanstveno izvirnost in relevantnost svojega dela.

V okviru tega predmeta se od študenta zahteva prisotnost in aktivno sodelovanje vsaj na petih predstavitev osnutkov dispozicij doktorskih disertacij oziroma doktorskih seminarjih ali zagovorih doktorskih disertacij drugih študentov ali na akademskih forumih Nove univerze.

European Faculty of Law of the New University. In accordance with the Regulations on Doctoral Study Programs of the European Faculty of Law of the New University, the student, among other things, presents the theoretical foundations of the studied topic, the research plan with research questions and the methodology. The student also explains the expected scientific originality and relevance of his work.

As part of this course, the student is required to be present and actively participate in at least five presentations or defences of draft dissertation proposals, doctoral seminars, or defences of doctoral dissertations of other student or at the academic forums of the New University.

Temeljni literatura in viri / Readings:

Znanstvena dela – članki, monografske publikacije, zborniki, arhivski in drugi viri iz izbranega področja, ki ga osnutek dispozicije obravnava.

Scientific literature – articles, monographies, miscellanea, archival and other resources on the chosen topic.

Cilji in kompetence:

Cilj je, da študent uspešno pripravi osnutek dispozicije doktorske disertacije, s čimer izkaže akademsko stopnjo znanstvenega načrtovanja.

Cilj je študenta usposobiti za samostojni, ustvarjalni in kakovostni študij.

Obveznost priprave osnutka dispozicije doktorske disertacije študenta usposobi za samostojno znanstvenoraziskovalno delo na izbranem področju. Študent pridobiva kompetence za raziskovalno delo, ki je osnova za izdelavo doktorske disertacije. Obenem študent razvija svoje pisne kompetence za nadaljnje pisanje doktorske disertacije.

Objectives and competences:

The student prepares a draft proposal of the doctoral dissertation, thereby demonstrating an academic level of scientific planning.

The aim is to prepare the student for independent, creative, and high-quality study.

The obligation to prepare a draft proposal of the doctoral dissertation prepares the student for independent scientific research work in the chosen field. The student acquires competencies for research work, which is the basis for the preparation of the doctoral dissertation. At the same time, the student develops writing skills for further writing of the doctoral dissertation.

Študent nadaljuje z razvojem sposobnosti evidentiranja problema in njegove analize ter sposobnosti uporabe pridobljenega teoretičnega znanja v praksi. Obenem študent razvija svoje pisne kompetence za nadaljnje pisanje doktorske disertacije. Preko ustne predstavitve osnutka dispozicije doktorske disertacije pred strokovno komisijo za oceno primernosti dispozicije doktorske disertacije študent razvija svoje retorične sposobnosti in argumentacijske spretnosti.

Z uvedbo seminarja se zagotavlja dodatna časovna kontrola in zgodnji pristop k načrtovanju doktorske disertacije, kar omogoča s študijskim programom predvideno odobritev osnutka dispozicije doktorske disertacije s strani strokovne komisije za oceno primernosti dispozicije doktorske disertacije in Senata Evropske pravne fakultete Nove univerze do konca prvega letnika.

The student continues to develop the ability to identify and analyse problems and the ability to apply acquired theoretical knowledge in practice. At the same time, the student develops writing skills for further writing of the doctoral dissertation. Through the defense of the draft proposal of the doctoral dissertation before a committee for the evaluation of the suitability of the dissertation proposal, the student develops his rhetorical abilities and argumentative skills.

The introduction of the seminar ensures additional time control and an early approach to doctoral dissertation planning, which allows for the approval of the draft proposal of the doctoral dissertation by a committee for the evaluation of the suitability of the dissertation proposal and by the Senate of the European Faculty of Law of the New University by the end of the first year.

Predvideni študijski rezultati:

Študent bo izdelal osnutek dispozicije doktorske disertacije, v skladu s katero bo v nadaljevanju študija izdelal svojo doktorsko disertacijo. Vsebino osnutka dispozicije bo študent predstavil in zagovarjal pred strokovno komisijo.

Znanje in razumevanje:

- pridobitev in osvojitve znanja z ožjega znanstvenega področja, v katerega sodi doktorska disertacija;
- naučiti se prenosa znanstvenega raziskovanja v proces pisanja;
- pridobiti kritičen in objektivni pristop do trditev in razumevanja znanstvene literature;
- naučiti se javno predstaviti svoje raziskovalno delo in ga ustrezno argumentirati.

Intended learning outcomes:

The student will complete his draft proposal of the doctoral dissertation based on which he will later develop his doctoral dissertation. The draft proposal will be presented before a committee.

Knowledge and understanding:

- Acquire and master knowledge in the specific scientific field to which the doctoral dissertation belongs.
- Learn to transfer scientific research into the writing process.
- Develop a critical and objective distance towards the arguments and understanding of scientific literature.
- Learn to publicly present and appropriately argue the research work.
