**Vsebina:**

**Content (Syllabus outline):**

Evidentiranje in upravljanje nepremičnin ter poznavanje zakonitosti prostora so temeljni elementi, na katerih gradijo razvoj uspešne ekonomije razvitih držav. Kataster nepremičnin je temeljna evidenca podatkov Republike Slovenije o nepremičnih. Združuje podatke zemljiškega katastra, katastra stavb in registra nepremičnin. Poleg te nepremičninske evidence so podatki o fizičnih lastnostih nepremičnin v Republiki Sloveniji zbrani še v evidenci državne meje, registru prostorskih enot, registru naslovov in zbirnem katastru gospodarske javne infrastrukture. Vpisu in javni objavi podatkov o pravicah na nepremičninah in pravnih dejstvih v zvezi z nepremičninami je namenjena zemljiška knjiga. Namensko in sistematično spremljanje, evidentiranje in upravljanje podatkov o nepremičninah pomeni združevanje in povezovanje lokacijskih in tehničnih podatkov o nepremičninah ter podatkov o pravicah na nepremičninah in pravnih dejstvih v zvezi z nepremičninami. Podatki in informacije, ki so zabeleženi v nepremičninskih evidencah, imajo izjemno pomembno vlogo v vseh družbenih in poslovnih okoljih ter predstavljajo enega temeljnih načel za nemoteno delovanje države in družbe. Poznavanje vsebin evidentiranja in upravljanja nepremičnin je zato za študente prava in managementa nepremičnin nujno, izbira tega izbirnega predmeta pa zato **zelo priporočljiva**.

Predmet »Evidentiranje in upravljanje nepremičnin« na doktorski ravni študija poglobljeno, kritično in primerjalno obravnava vsebine, ki se nanašajo na evidentiranje in upravljanje nepremičnin, registre, katastre, informacijske sisteme, podatkovne baze, pravne, institucionalne in organizacijske okvire v zvezi z evidentiranjem in upravljanjem nepremičnin ter s tem povezane razvojne trende.

Real estate recording and management of along with an understanding of spatial legality, are fundamental elements upon which the development of a successful economy in developed countries is built. The real estate cadastre is the fundamental record of data of the Republic of Slovenia regarding properties. It combines data from the land cadastre, building cadastre, and real estate register. In addition to this real estate record, data on the physical properties of real estate in the Republic of Slovenia are also collected in the state border register, the register of spatial units, the register of addresses and the collective cadastre of economic public infrastructure. On the other hand the land register is a public record designed for the recording and public disclosure of information regarding property rights and legal matters associated with real estate. The purposeful and systematic monitoring, recording, and management of real estate data entail the merging and interlinking of locational and technical information concerning real estate, as well as data concerning property rights and legal facts related to real estate. Data and information recorded in real estate records play an extremely important role in all social and business environments and represent one of the fundamental principles for the smooth functioning of the state and society. Knowledge of real estate recording and management is therefore essential for students of law and real estate management, and the choice of this elective course is therefore highly recommended.

The course "Real estate recording and management" at the doctoral level of study deals with an in-depth, critical and comparative treatment contents area related to real estate recording and management, registers, cadastres, information systems, databases, legal, institutional and organizational frameworks related to the real estate recording and management as well as related development trends.
