The proposal of the doctoral dissertation must include all the components provided by the Regulations. In the doctoral dissertation proposal, the student precisely defines his hypotheses or research questions, individually designs the scientific research work and the research problem, defines the objectives and

The doctoral dissertation proposal has to be approved by the Senate of the European Faculty of Law of the New University.
