Študent nadaljuje s pripravo doktorske disertacije, pri čemer se individualno znanstveno-raziskovalno delo, ki ga usmerja mentor, izkazuje v obliki končne doktorske disertacije. V doktorski disertaciji pokaže kandidat poleg usposobljenosti za znanstveni način mišljenja in sposobnosti raziskovalnega dela tudi izvirne prispevke k znanosti in stroki.

Pred zagovorom študent objavi oziroma ima v objavo sprejet najmanj en izvirni znanstveni članek s prvim avtorstvom iz vsebine doktorata v publikaciji, ki jo veljavna habilitacijska merila Nove univerze upoštevajo za izvolitev v naziv

**Content (Syllabus outline):**

The student continues with the preparation of the doctoral dissertation, whereby the individual scientific research work directed by the mentor is manifested in the form of a final dissertation.

Before the defense, the student publishes, or has accepted for publication, at least one original scientific article with first authorship from the content of the doctorate in a publication that is considered by the valid habilitation criteria of the New University for election to the title of higher education teacher. If first authorship is not possible (e.g. in the

Če prvo avtorstvo ni mogoče (npr. pri mednarodnih raziskavah ali iz drugih opravičljivih razlogov), mora mentor dati izjavo, da je prispevek doktoranda v članku pomemben.

Pri vseh objavah, povezanih z raziskovalnim delom v okviru doktorskega študija, mora biti navedena afilijacija »Nova univerza«. To velja tudi v primeru, ko so doktorand, mentor ali somentor zaposleni v drugi organizaciji.

Po objavljenem znanstvenem članku in, ko je doktorska disertacija s strani mentorja oz. Komisije za oceno doktorske disertacije pozitivno ocenjena in sprejeta, določi Senat NU, Evro-PF Komisijo za zagovor doktorske disertacije, ki jo praviloma sestavljajo člani Komisije za oceno doktorske disertacije.

Zagovor doktorske disertacije je študentu omogočen pod pogojem, da ima študent opravljene vse obveznosti po programu.

case of international research or for other justifiable reasons), the supervisor must make a statement that the doctoral student's contribution to the article is important.

In all publications related to research work within the framework of doctoral studies, the affiliation "New University" must be indicated. This also applies if the doctoral student, supervisor or co-supervisor is employed in another organization.

When the scientific article is published and when the doctoral dissertation is positively evaluated and accepted by the mentor and committee for the evaluation of the doctoral dissertation, the Senate NU, Evro-FL, appoints the thesis Committee for the defence of the doctoral dissertation, which usually consists of members of the Committee for the evaluation of the doctoral dissertation.

The defence of the doctoral dissertation is possible when student has completed all obligations under the program.

#### **Temeljni literatura in viri / Readings:**

Znanstvena dela – članki, monografske publikacije, zborniki, arhivski in drugi viri iz izbranega področja, ki ga osnutek dispozicije obravnava.

Scientific literature – articles, monographies, miscellanea, archival and other resources on the theme.

#### **Cilji in kompetence:**

Študent pripravi doktorsko disertacijo in jo zagovarja pred Komisijo za zagovor doktorske disertacije. Pred zagovorom je zahtevana objava znanstvenega članka, ki študentu zagotovi aplikativno znanje objavljanja znanstvenih rezultatov.

Cilj je, da študent uspešno konča s pisanjem doktorske disertacije, s čimer izkaže visoko akademsko stopnjo znanstvenega načrtovanja.

#### **Objectives and competences:**

The student prepares a doctoral dissertation and defends it before the thesis committee.

Prior to the defense, the publication of a scientific article is required, which provides the student with the applied knowledge of publishing scientific results.

The aim of the obligation is to prepare the student for in-depth independent, creative and quality study.

Študent nadaljuje s pridobivanjem kompetenc za raziskovalno delo. Študent nadaljuje z razvojem sposobnosti evidentiranja problema in njegove analize ter sposobnosti uporabe pridobljenega teoretičnega znanja v praksi.

Obenem študent razvija svoje pisne kompetence za dokončanje doktorske disertacije in znanstvenega članka in že obvladuje predstavitev raziskovalnih dosežkov v pisni in ustni obliki, kar izkazuje končni zagovor doktorske disertacije.

The student continues to acquire competencies for research work. At the same time, the student develops his writing competencies for further writing of the doctoral dissertation and scientific article.

At the same time, the student develops his writing competencies for the completion of the doctoral dissertation and scientific article and already masters the presentation of research achievements in written and oral form, which is reflected in the final defense of the doctoral dissertation.

#### **Predvideni študijski rezultati:**

Študent bo dokončal pisanje doktorske disertacije, objavil znanstveni članek in uspešno zagovarjal doktorsko disertacijo.

Znanje in razumevanje:

- Pridobitev in osvojitve znanja z ožjega znanstvenega področja, v katerega sodi doktorska disertacija.
- Naučiti se prenosa znanstvenega raziskovanja v proces pisanja.
- Pridobiti kritičen in objektivni pristop do trditev in razumevanja znanstvene literature.
- Naučiti se uspešno javno predstaviti svoje raziskovalno delo.

#### **Intended learning outcomes:**

The student will complete the writing of the doctoral dissertation, publish a scientific article and successfully defend the doctoral dissertation.

Knowledge and Understanding:

- Acquire and gain the knowledge from a narrower academic field, a part of which is a Ph.D. thesis.
- Learn to transfer the scientific research in a written form.
- Gain critical and objective distance towards the arguments and understanding of scientific literature.
- Learn to successfully present research work publicly.

#### **Metode poučevanja in učenja:**

Oblike dela vključujejo frontalno obliko poučevanja in samostojno delo študentov.

Študent deluje večinoma samostojno raziskovalno, pri tem mu pomaga mentor, ki ga tudi ustrezno usmerja.

#### **Learning and teaching methods:**

Forms of work include a frontal approach of teaching and independent work of students.

Student work is mostly individual, monitored, assisted and directed by the mentor.
