**Content (Syllabus outline):**

The student prepares the disposition according to the Rules and regulation of NU, Euro-FL.

The disposition of the doctoral dissertation must include all the components provided by the Rules (Title of the doctoral dissertation, Explanation of the topic; Research issue, subject and hypotheses; Research purpose and objectives; Evaluation of the research to date; Research methods; A brief outline of the foreseen chapters; Expected research results;

in stroki; uporabo rezultatov raziskovanja; jedro literature in virov (vsaj sto enot); podatke o študentu (curriculum vitae) s poudarkom na študentovem razvoju na znanstvenem področju ter bibliografijo študenta).

Študent v dispoziciji doktorske disertacije natančno opredeli svoje hipoteze oz. raziskovalna vprašanja, individualno zasnuje znanstvenoraziskovalno delo ter problem raziskovanja, opredeli cilje in metodologijo, določi naslov doktorske disertacije ter izbere relevantno literaturo, ki jo bo uporabil pri izdelavi doktorske disertacije. Obenem že opredeli tudi predvidena poglavja ter pričakovane rezultate raziskovanja ter prispevek k znanosti in stroki. S tem študent razvija svojo doktorsko temo.

Pripravljena dispozicija doktorske disertacije je rezultat raziskovalnega dela študenta v sodelovanju z mentorjem, ki ga pri delu spremlja in usmerja.

Dispozicijo doktorske disertacije študent zagovarja pred Komisijo za oceno dispozicije doktorske disertacije, ki jo določi Senat NU, Evro-PF.

Expected contribution to science and the profession; Application of the research results; Main literature and sources (at least 100 units); Student's information (curriculum vitae) with an emphasis on the student's development in the scientific field; Student's bibliography).

In his disposition of the doctoral dissertation student precisely defines his hypotheses or research questions, individually designs scientific research work and research problem, defines the goals and methodology, determines the title of the doctoral dissertation and selects the relevant literature that will be used in the preparation of the doctoral dissertation. At the same time, student already defines the envisaged chapters and the expected results of the research, as well as the contribution to science and the profession.

The prepared disposition of the doctoral dissertation is the result of the student's research work in cooperation with the mentor, who monitors and guides him at his work.

The student defends the disposition of the doctoral dissertation before the Committee for the evaluation of the disposition of the doctoral dissertation, which is determined by the Senate of NU, Evro-FL.

### **Cilji in kompetence:**

Cilj je, da študent uspešno pripravi dispozicijo doktorske disertacije, s čimer izkaže akademsko stopnjo znanstvenega načrtovanja.

### **Objectives and competences:**

The student proves his/her academic competence on scientific planning by preparing a good disposition of the doctoral dissertation.

Cilj obveznosti je študenta usposobiti za samostojni, ustvarjalni in kakovostni študij.

Obveznost priprave dispozicije doktorske disertacije študenta usposobi za samostojno znanstvenoraziskovalno delo na izbranem področju. Študent pridobiva kompetence za raziskovalno delo, ki je osnova za izdelavo doktorske disertacije študenta. Obenem študent razvija svoje pisne kompetence za nadaljnje pisanje doktorske disertacije in znanstvenega članka.

Študent nadaljuje z razvojem sposobnosti evidentiranja problema in njegove analize ter sposobnosti uporabe pridobljenega teoretičnega znanja v praksi.

Preko zagovora dispozicije doktorske disertacije pred Komisijo za oceno dispozicije doktorske disertacije študent razvija tudi svoje retorične sposobnosti.

The aim of the obligation Doctoral Seminar 1 is to train the student for independent, creative and quality study.

Obligation of preparing the disposition of the doctoral dissertation prepares student for independent scientific research work in a selected field. The student acquires competencies for his research work, which is the basis for the preparation of the student's doctoral dissertation. At the same time, the student develops written competencies for further writing of the doctoral dissertation and scientific article.

The student continues to acquire competencies for research work. The student continues to develop the ability to record the problem and its analysis, as well as the ability to apply the acquired theoretical knowledge in practice.

Through the defense of the disposition of the doctoral dissertation before the Committee for the evaluation of the disposition of the doctoral dissertation, the student also develops his rhetorical skills.

#### **Predvideni študijski rezultati:**

Študent bo izdelal dispozicijo doktorske disertacije, v skladu s katero bo v nadaljevanju študija izdelal svojo doktorsko disertacijo. Dispozicijo doktorske disertacije potrdi Senat NU, Evro-PF.

Znanje in razumevanje:

- Pridobitev in osvojitve znanja z ožjega znanstvenega področja, v katerega sodi doktorska disertacija.
- Naučiti se prenosa znanstvenega raziskovanja v proces pisanja.
- Pridobiti kritičen in objektivni pristop do trditve in razumevanja znanstvene literature.
- Naučiti se uspešno javno predstaviti svoje raziskovalno delo.

#### **Intended learning outcomes:**

The student will complete his disposition of doctoral dissertation that will be the frame for the preparation of dissertation. The disposition of the doctoral dissertation is confirmed by the Senate of NU, Euro-FL.

Knowledge and Understanding:

- Acquire and gain the knowledge from a narrower academic field, a part of which is a Ph.D. thesis.
- Learn to transfer the scientific research in a written form.
- Gain critical and objective distance towards the arguments and understanding of scientific literature.
- Learn to successfully present research work publicly.

**Metode poučevanja in učenja:**

Oblike dela vključujejo frontalno obliko poučevanja in samostojno delo študentov.

Študent deluje večinoma samostojno raziskovalno, pri tem mu pomaga mentor, ki ga tudi ustrezno usmerja.

Študent pripravi dispozicijo v skladu s Pravilnikom o študiju na NU, Evro-PF. Dispozicijo doktorske disertacije potrди Senat NU, Evro-PF.

**Learning and teaching methods:**

Forms of work include a frontal approach of teaching and independent work of students.

Student work is mostly individual, monitored, assisted and directed by the mentor.

Student prepares disposition of doctoral dissertation in accordance with the Rules and regulation of NU, Euro-FL. The disposition of the doctoral dissertation is confirmed by the Senate of NU, Euro-FL.
